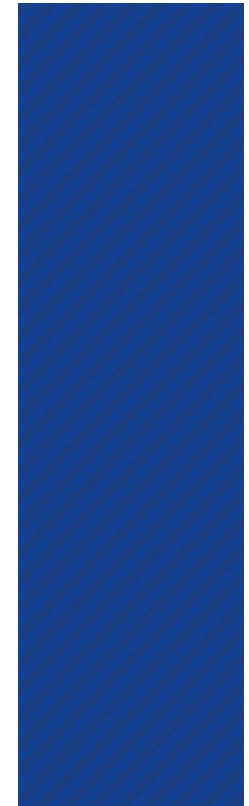

## Our experience

- **Avsec Cargo** is a Regulated Agent with the number **RA / PL / 00044 - 01 and RA / PL / 00044 - 02** approved by the President of the Civil Aviation Authority in two locations: Warsaw and Wysogotowo near Poznan.
- For 14 years we have been implementing security solutions in air transport and conducting stationary and e-learning training.
- We developed a database of customers who participate in the secure SPX supply chain and meet the requirements of aviation security.
- We have created a tool that allows us to take responsibility for a secure supply chain under our declaration and RA number. This is possible thanks to the access to all documents of persons participating in the entire chain, i.e. background checks and driver training certificates.





## Umbrella SPX – what is it?

- ✈ A service dedicated to shipping companies and road hauliers delivering air cargo.
  - ✈ It enables forwarders to access transport companies with SPX status verified by Avsec Cargo.
  - ✈ It enables transport companies to join a secure supply chain with SPX status signed by Avsec Cargo, as well as receiving additional orders from shipping companies.

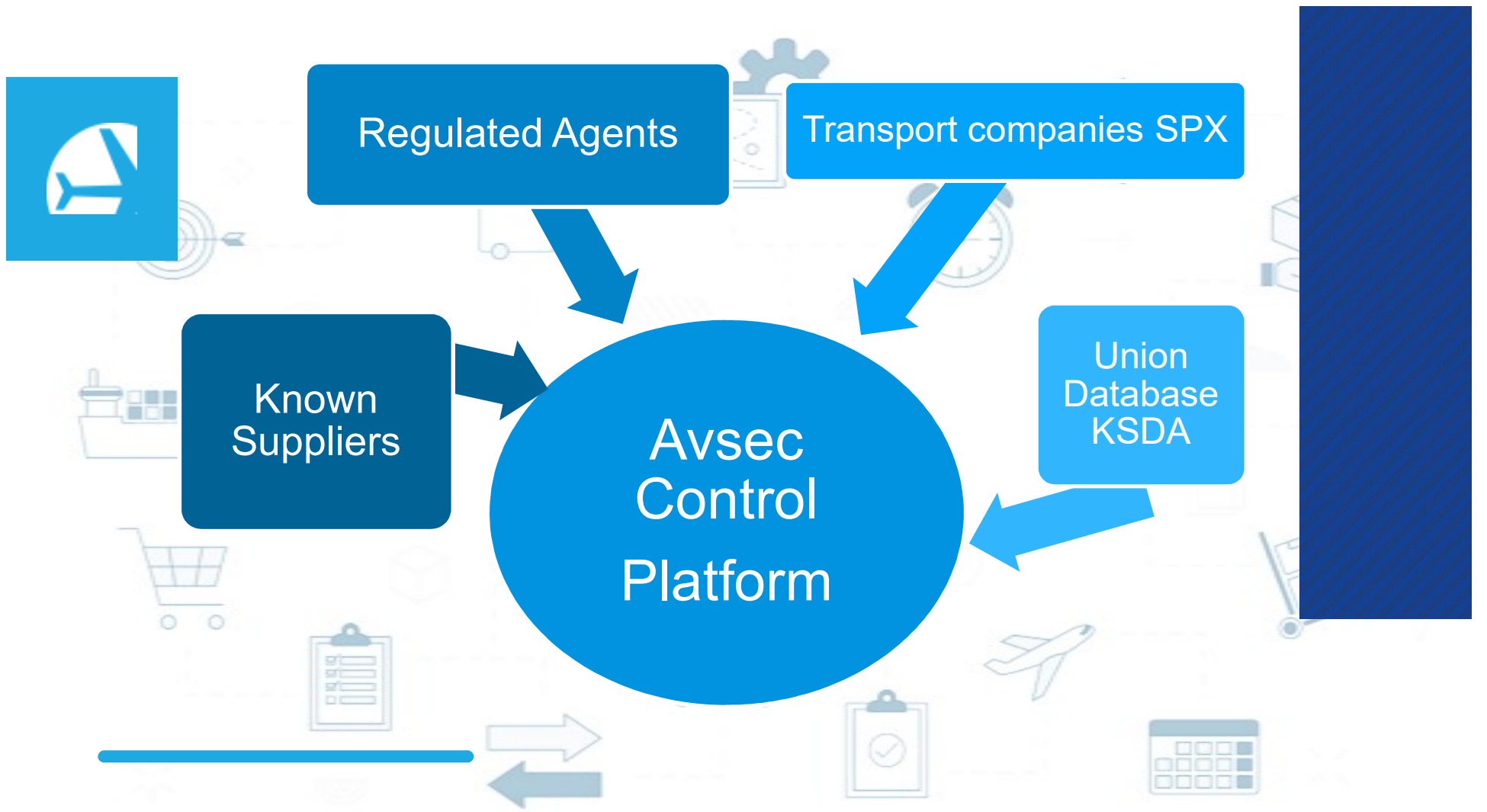




## Umbrella SPX by Avsec Cargo

- ✈ **Avsec Cargo** connects freight forwarders and road hauliers for cooperation.
- ✈ We verify employees of the road carrier for the forwarding company in terms of checking the background check and the required training via the Avsec Control Platform.
- ✈ We take responsibility for the compliance of the road carrier's documents with the provisions of Polish and EU law in the field of security.
- ✈ The **Avsec Control** platform keeps records in an electronic form.
- ✈ The forwarder receives additional transport companies for cooperation, and the transport company by joining the security supply chain thanks to the **SPX Umbrella**, can carry out new orders that were previously unavailable.

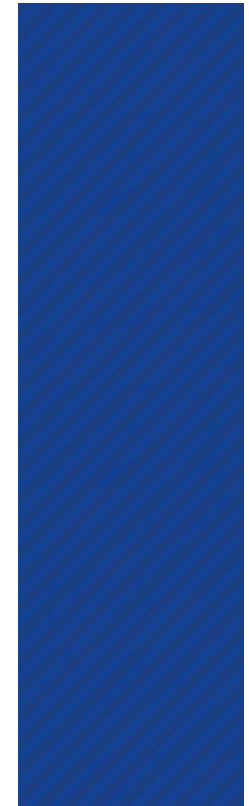






# Avsec Control Platform

- ✈ The **Avsec Control platform** is an online tool that connects companies participating in a secure supply chain.
  - ✈ This tool **takes the responsibility off** shippers and allows them access to transport companies that meet all the requirements for a secure supply chain.
  - ✈ Currently, the platform is used by **over 100 companies** with **15,000 active users**.
  - ✈ The Avsec Control platform is connected in real time to the **EU's KSDA database** (EU database for secure supply chain).

- Access to the unique air transport market.



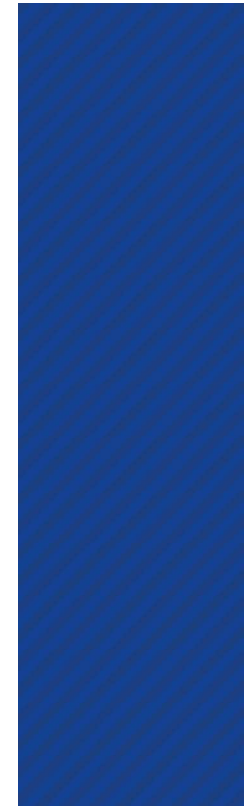

# What are you paying for?



## Transport company

- ✈ Fee for the SPX declaration issued by the transport company - **PLN 100** / for the issued declaration valid for 2 business days.
  - ✈ User registration / background check confirmation fee - **PLN 100** net per person
  - ✈ Training fee, depending on the training scope, **from PLN 100 to PLN 200**
  - ✈ **Quarterly settlements** based on the report on the used declarations, generated by the system, which is the basis for issuing a VAT invoice.
